## The OSHA Outreach Training Program

Before a trainer can offer OSHA Outreach Training, and issue completion cards, they must first be authorized by the U.S. Department of Labor. This authorization must be maintained. The Center Staff, and many of it's Worker Trainers, are authorized to provide, and issue completion cards, for the General Industry and Construction 10-hour and 30-hour Outreach Training. The Center uses the same award winning adult participatory approach to the OSHA Outreach Training as it does for all its occupational safety and health training.

OSHA created the Outreach Training Program to assist employers in making their workplaces safer and healthier. The more workers a workplace has that understand the principals of occupational safety and health the easier it is to promote a safety and health conscious workplace environment.

OSHA requires certain subjects be covered in the outreach training and they allow for electives of other occupational safety and health subjects. For a complete list of both required and elective subjects contact the Center.

### General Industry or Construction

The Center is authorized to provide OSHA Outreach Training, and issue completion cards, in both General Industry and Construction.

### OSHA 500 and OSHA 501

Through it's affiliation with various OSHA Educational Centers the ICWUC Center for Worker Health and Safety Education is authorized to offer the OSHA 500 and OSHA 501, as well as other OSHA courses. The OSHA 500 is a trainer course in occupational safety and health standards for the construction industry. This course is designed for personnel in the private sector interested in teaching the 10 and 30 hour outreach construction training programs.

The OSHA 501 is a trainer course in occupational safety and health standards for General Industry . This is a trainer course for personnel from all types of industry. Upon successful completion of this course, trainees will be authorized to teach the 10 and 30 hour outreach for general industry.

If you are looking to provide OSHA Outreach Training and issue completion cards to your workers yourself, then the OSHA 500 and/or the OSHA 501 would benefit you. When it is time for your trainers to be updated and maintain their authorization the Center offers the OSHA 502 (update for construction industry outreach trainers) and the OSHA 503 (update for general industry outreach trainers).

### OSHA 7600 Disaster Site Worker

This course is highly recommended by OSHA for any worker assigned to a disaster relief effort such as Katrina.
